## PRELUDE

1. **Principal (paying) members cannot utilize these facilities until they have attended the required in-person orientation class of the Range Rules and Safety Plan. All club memberships expire each year on July 31. The Club's fiscal year is from August 1 to July 31 of the following year. All eligible applicants for membership must annually sign 1) *Application for Membership*, 2) a receipt of *Range Rules and Safety Plan* with acknowledgement to abide by them and 3) a signed Release of Liability and Assumption of Risk of Dangers and Hazards.**
2. **In order to become a member, applicants must attend a scheduled *Orientation and Safety Class* to conclude the process of membership eligibility. These mandatory classes will be available several times during the annual membership renewal period (typically from May 1 to July 31 but can be extended by the Board of Directors), and dates and times will be published on the Club's Facebook page and/or by email.**
3. **Opening and closing of the Club gate:** Club gate must be kept locked at all times unless there is a club sponsored event.
4. **Sign in and paying fees:** All members and their guest(s) must sign in and pay the range fees prior to the usage of the specific range they will be utilizing. Exception is the usage of the shotgun ranges where the fee will be paid on the total per rounds used. All guests must sign a liability release form each and every time they come to the range. Liability release forms are located in the sign in boxes at each range.
5. **Secured firearms: This facility is considered a COLD RANGE** meaning all firearms must be unloaded before leaving the main gate area. According to the **Four Cardinal Rules of Firearms Safety** , all firearms are considered loaded so treat all firearms as if they are. All chamber actions, slides, bolts should be locked open (or have chamber flag inserted) and magazines removed prior to leaving your vehicle and walking up to the range(s). **THIS INCLUDES ALL CONCEALED AND OPEN CARRY FIREARMS.**
6. **Possession of firearm:** Anyone who cannot legally possess a firearm, is not permitted to handle firearms on these facilities.
7. **Background check:** All principal members are subject to a background check.
8. **Hunting is PROHIBITED on Club property.**

## 9. Definition of Club Sponsored Events:

- a. A designated Club Member will serve as Event Coordinator and will be responsible for the event and named in all promotions of the event as the contact person.
- b. The Front Gate will be left open during the event and closed and locked when the event is finished and all non-members have left the club property.
- c. \$20 will be the minimum entry fee and NO COUPONS will be accepted as payment
- d. The event will be Open to non-club members
- e. All participants in the event will be required to sign a Liability Release (Waiver).
- f. Notice of the event will be sent to Membership via the club email (i.e. Mailchimp). Other non-members may also be notified.

## Overview

This safety plan has been established to ensure the safety of those individuals who use this facility and the community at large. The rules and regulations in this document are to ensure the continuity of this facility and the continued safety of users and neighbors of this facility.

The use of the real and personal property of the Cuero Sportsman Club, Inc. ("Club" or "CSC") is a privilege, and the use of firearms is an inherently dangerous activity. The improper use of firearms on club property is strictly prohibited. Your activities and actions must always be conducted in a manner that is consistent to safeguard yourself and others against harm or injury, and property against damage and destruction. The rules in this safety plan shall be adhered to in order to protect the lives and safety of all and preserve your privilege.

The Officers, Range Officers or Directors-at-Large shall have the authority to take immediate action to temporarily suspend range privileges of users found violating the Range Rules and Safety Plan. Pending action after investigation and/or hearing and action by a majority of the Board of Directors, violations of these rules can lead to temporary suspension from the Club, revocation of

membership and termination in use and privileges, or forfeiture of member's dues. Trespass charges for violation of any of these suspensions or restrictions may be prosecuted by the Board of Directors of Cuero Sportsman Club, Inc.

The structure of this document and the Gun Handling Rules are taken from "*The NRA Range Source Book*." These rules comply with the recommendations of the NRA.

## **RANGE OFFICER'S DUTIES**

1. It shall be the duty of the Range Officer(s) to ensure the safe handling of firearms and the overall safety and conduct of all members and guests while on Club property. Failure on the part of any person to comply to their directives may result in the expulsion of said member or guest from the Club property permanently by action of the Board of Directors.
2. When two or more members are present on the firing line, one member must act as a Range Officer.
3. The Range Officer has the full and final authority and responsibility for the safe and efficient conduct of the shooting on the range.
4. The Range Officer has the power to expel any person or persons who do not obey all Range Rules and Safety Plans or who jeopardize the safety of any person on the range.
5. A report of any incident and the name of the offender must be presented to a member of the club's Board of Directors.
6. Any dispute with a decision or instruction of the Range Officer must be brought before the Board of Directors for resolution.
7. The Range Officer must ensure that only approved targets are used and that they are placed so that all projectiles from aimed shots will be captured by the backstop.
8. The Range Officer must be familiar with the layout of the particular range prior to commencing firing.
9. The Range Officer is responsible for the calling of all Cease Fires and other instructions to the shooter(s).

10. It is the responsibility of the Range Officer to personally check and ensure the firearms are clear of each shooter on the firing line prior to any person moving forward of the firing line or any person removing a firearm from the firing line.

## Section 1 - Gun Handling Rules

**SAFETY AND PROPER GUN HANDLING ARE OF EXTREME IMPORTANCE IN AVOIDING ACCIDENTS AND INJURIES.**

**Memorize the following Four Cardinal Rules of firearms safety and treat them with absolute seriousness at all times.**

- 1.1 **(1) ASSUME ALL GUNS ARE ALWAYS LOADED.**  
A large percentage of firearm related mishaps occur with the so called "Unloaded Firearm."
- 1.2 **(2) NEVER LET THE MUZZLE OF THE FIREARM BE POINTED AT OR COVER ANYTHING YOU ARE NOT WILLING TO DESTROY.**  
This is the most violated rule and is always excused with "It's not loaded." No matter where you are on the club's ranges, no matter if the range is HOT or COLD, if there is someone between you and the backstop and you are handling an uncased firearm you are in violation of the rule.
- 1.3 **(3) KEEP YOUR FINGER OFF THE TRIGGER AND OUT OF THE TRIGGER GUARD UNTIL YOUR SIGHTS ARE ON THE TARGET AND YOU ARE READY TO FIRE.**
- 1.4 **(4) BE SURE OF YOUR TARGET AND WHAT'S BEHIND IT AND WHAT'S IN FRONT OF IT.**  
Never shoot at anything you have not positively identified. REMEMBER! You are morally, ethically, and financially responsible for your bullet and the damage that it causes until that bullet comes to its final resting place on this earth.
- 1.5 Keep the action open, a chamber flag in the open ejection port, and the firearm unloaded until ready to use. Rifles and shotguns must be placed in the racks during a cease-fire and when not in use. Break-action

shotguns may be closed while in the rack but must be opened as soon as they are removed from the rack. All other shotgun and rifle action types shall have the action open while on the range or in the rack unless the shooter is on a station and ready to shoot.

- 1.6 **Eye and hearing protection is REQUIRED** for everyone on all the ranges while the range is “HOT.” Eye protection is defined as lenses covering your eyes. Half-glass frames (*reading glasses*) are not appropriate eye protection. Eye protection should be worn so it covers your eyes. Hearing protection should be worn over or in the ears. A hat or cap of some sort is recommended.
- 1.7 **Do not mix alcohol or drugs with shooting activities. Alcohol consumption is prohibited until shooter has completed firing and gun is secured for travel away from the firing line.** If a person is taking a prescription or an over-the-counter drug bearing a warning about operating machinery, driving etc., or any substance which adversely affects their individual shooting activities, that person will refrain from any shooting activities until free from the effects of the drug or substance.
- 1.8 **Be sure your firearm and ammunition are compatible.** Carry only the correct gauge or caliber/cartridge ammunition for the shotgun, rifle, or handgun you are currently shooting. When switching to a different gauge or caliber of weapon, separate and secure the ammunition that was previously being used.

**Range Definitions.** As used in these Rules, Skeet, Trap, Country Double, and other types of ranges established to NORMALLY fire shotguns are differentiated from rifle or handgun ranges. The term “Shotgun Range” will refer to any permanent range reserved for the firing of a shotgun; specifically, those for skeet, trap, and country double, including any temporary range set up for use in firing a shotgun.

**The ranges at the club are identified as follows:**

**Shotgun Ranges – Skeet, Trap and Country Double**

**100-yard Rifle Range**

**15-yard and 25-yard Handgun Ranges**

**50-yard .22 LR Range (.22 LR Only, No .22 Magnum, No 17 HMR)**

**15-yard and 25-yard Handgun Ranges** Firearms are to be fired at ranges not closer than 3 yards and not to exceed the designated yardage on the specific ranges. Only rim-fire handguns and rifles and all-caliber handguns may be fired on these ranges. Pistol caliber carbines (PCC's) are allowed on the 15 yard and 25 yard Handgun Ranges chambered only in 9mm, 40 S&W and 45 ACP. Center Fire Rifles are NOT permitted on these ranges.

**The 50-yard .22 LR Range is designated as a .22 LR Range ONLY.** This range is for .22 LR rifles and handguns. No other firearms may be fired on this range. That means NO center-fire handguns or rifles including PCC's or shotguns may be fired on this range. It also means NO .22 Magnum and NO 17 HMR. **THE 50-YARD .22 LR RANGE IS FOR 22 LR ONLY.**

**100-yard Rifle Range:** Firearms are to be fired at either the 25 yard, 50 yard, 75 yard or the 100 yard backstops on this range. Both rim fire and center fire rifles and handguns may be fired on this range. **Shotguns are permitted ONLY on the 25-yd berm and only using the pipe stand with cattle panel for patterns. SHOTGUNS are allowed only on the Shotgun Ranges and 25-yard berm of the 100-Yard Rifle Range.**

**At the 25-yard berm of the Rifle Range shotguns can be used ONLY with the PIPE TARGET STAND with cattle panel. DO NOT FIRE SHOTGUNS AT THE STANDS MADE OF WOOD. DO NOT FIRE CENTER FIRE RIFLES OR HANDGUNS AT THE PIPE TARGET STAND WITH CATTLE PANEL (THAT STAND IS STRICTLY RESERVED FOR SHOTGUNS.)**

**ALL targets must be placed in close proximity to the backstops. Do not move targets closer to the firing line, or in the case of the 100-yard Rifle Range, out in the middle of the range.**

**Whether on the 100/50/25/15 yard ranges, all shooters must be on the same line in distance from the targets.**

**Armor-piercing rounds and incinerating rounds are prohibited. No cartridge longer than 3-3/4" in length can be used on any range.**

Rifle/Handgun Ranges are to be shared, and no member is to be excluded from participating in the use of the ranges. The use of the rifle/handgun

ranges is to be limited to thirty (30) minutes if others are waiting to use the range.

## **Section 2 – Rifle, Handgun & .22LR Range Rules**

- 2.1 Know where others are at all times. The down-range target area shall be checked before any firing commences. Non-shooters must be in the safety zones immediately behind the current shooting station or completely off the range before loading or shooting commences. Due to the close proximity of the various ranges, it is essential that each shooter maintains muzzle control and ensures the ranges are clear prior to shooting.
- 2.2 During a cease fire, the firearm is to be unloaded, the breach open, magazine removed, and a chamber flag inserted into the breach. Where gun racks are available, firearms are to be placed into the racks during a cease fire.
- 2.3 Do not load or fire your rifle, handgun, or shotgun unless you are on or at an established or provisional shooting station. All firearms are to be treated as loaded at all times. If the chamber or any part of the firearm is occupied by a cartridge, shell, or hull, it is considered loaded.
- 2.4 Firearms will be unloaded, and the action will be open before stepping off the shooting station/line.
- 2.5 If a shell misfires keep the weapon pointed down range for a minimum of 30 seconds before clearing and unloading. It is recommended that misfired shells not be placed in your pocket or pouch containing other ammunition.
- 2.6 Any shooter whose firearm accidentally discharges for any reason shall be required to exchange that firearm or, if time permits, make repairs before continuing to shoot.
- 2.7 Full-automatic/semi-automatic firearms: The use of ANY full-automatic weapon on club property is restricted to Law Enforcement Personnel in the process of supervised training and maintaining their proficiency certification under the supervision of their certifying officer. **The use of rapid-fire devices (bump stocks, binary triggers, and other special trigger**

**devices, etc.) is prohibited.** Firearms so equipped may be used if locked into a conventional semi-automatic mode, i.e., one trigger pull, one round discharged. This is a demonstrated safety issue. Violators will be disciplined.

- 2.8 Engagement of any targets by UNSAFE, methods/approach is PROHIBITED. No “ground rolls” or the like, no shooting from behind make-shift barricades and no shooting from vehicles, tripod type deer stands and the like.

**Approval by the Board of Directors has been given to supervised groups, or the like, to use their portable shooting barriers during their matches.**

- 2.9 When rapid firing, all rounds must impact your target inside the target frame. No exceptions.
- 2.10 **Pistol Caliber Carbines are allowed only on the 15-yard and 25-yard handgun ranges in 9mm, 40 S&W, and 45 ACP calibers only. No PCC's allowed on the 50-yard .22 LR Range. PCC's may be shot on the 100-Yard Rifle Range in any caliber allowed on the 100-yard Rifle Range. There is no rule concerning minimum barrel length. The firearm must have a stock attached and be capable of being fired from shoulder position. Compensators/muzzle brakes are permitted. Suppressors are permitted. All references to “handgun” are deemed to apply to PCC as well for 9mm, 40 S&W and 45 ACP calibers, except where the terms “holstering”, drawing, or “re-holstering are used.**

**Semi-auto function only (one trigger pull fires one round). Short Barreled Rifles (SBR's chambered only in 9mm, 40 S&W and 45 ACP) may be used only on the 15-yard and 25-yard Handgun Ranges and the 100-yard Rifle Range. The owner of the SBR must be in full compliance with all state and federal laws and regulations concerning ownership and transport of the SBR. SBR's chambered in anything other than 9mm, 40 S&W and 45 ACP, must be shot only on the 100-yard Rifle Range. Handgun to carbine conversions are allowed as long as the conversion meets all of the criteria in these rules pertaining to PCC's.**

**.22 LR rifles and handguns may be shot on any handgun, rifle or 22. LR range.**

## Targets: The following rules apply:

**ONLY paper targets are to be used on the rifle/handgun ranges.** Glass, metallic or plastic bottles, metal cans and improvised targets are NOT permitted. Usage of other types of targets in an approved supervised club event may be used with the approval of the Board of Directors. Approved targets are located in the black box by the 100-yard range and are 2 for \$1.00 Place the money in the payment containers in the black box. Clothes pins for hanging your targets are located in ammo boxes at all ranges. Safety glasses and chamber flags are located there as well.

- a. The use of explosive or detonating targets or substances is expressly prohibited due to the extreme safety hazard of use.
- b. Backstops: The targets are to be placed close to the backstops to prevent and/or minimize ricochets.**
- c. Targets ARE NOT to be placed at mid-range distances, or any other distance from the backstop. **This is essential to prevent potential accidents, ricochets, and injuries.**
- d. Intentional shooting** of the target frames will not be tolerated. **There are two (2) target stands at the 25-yard backstop of the Rifle Range. The wood stand is for centerfire rifles and hand guns ONLY; the pipe stand with cattle panel is for shotguns ONLY.** Targets are to be hung in the designated place on the target wire utilizing clothes pins. The center of the main bullseye on the target will be no more than 48" above the ground and no closer to the ground than 24". All target frames must be against the backstop. **Shooting into the side berms is strictly prohibited.**
- e. There are site specific target frames (swingers) on the 15-yard, 25-yard and 50-yard .22 LR ranges that are utilized during Club sponsored 22 LR events. These frames are designed for use only with 22 LR rounded lead bullets. On the 15-yard and 25-yard ranges, these target frames are to be used only during special sponsored events. DO NOT MOVE THESE TARGET FRAMES AND DO NOT SHOOT AT THEM.**

**The 50-yard .22 LR Range is the designated for .22 LR only. The target frames with swinging targets MAY BE shot on this range, but do not move the frames. Shoot .22 LR only at these targets.**

- f. No Club property, including shade awnings, chairs, benches, tables, trees etc., is to be used as targets or target stands. Only club provided or approved target frames are to be used.
- g. Your used or unused targets on the target frames are to be removed and placed in the trash containers. Show some courtesy and leave the area clean for the next shooter. **You are responsible to clean up the ranges** when you have completed your shooting. All rifle/handgun cartridges (“brass”) and all shotgun hulls must be removed from the range surface and disposed of in an appropriate manner.
- h. Handguns and rifles may only be fired on the handgun/rifle/.22 LR ranges at approved targets. No rifle/handgun/.22 LR shots are to be fired except at approved targets, using the **backstops**, as previously noted. **No shooting at side berms.**

### **Section 3 - Shotgun Range Rules**

- 3.1 All break-open shotguns must have the action opened and carried in a manner on the shoulder where the barrel(s) are pointed down and towards the front of the shooter. Under no circumstances will the barrel(s) be pointed behind the shooter. All semi-auto and pump-action shotguns must have the actions locked open and carried in the port arms position with the open action facing outward of the shooter.
- 3.2 On the skeet, trap, and country-doubles ranges, only one person may fire at a time, and only one shot per clay (target) is permitted. Special events requiring other types of shooting must be approved by the Range Officer or the Board of Directors.
- 3.3 Skeet Shooting: Only two shells may be loaded on all stations. At station 8 only one shell may be loaded for the high house and one at the low house, but two shells may be for the low house if the shooter has two shots left in the round at this station. Again, no more than two shells are to be loaded in a shotgun on any of the Skeet, Trap or Country Doubles fields.

- 3.4 If a shell misfires, keep the weapon pointed down range for a minimum of 30 seconds before clearing and unloading. It is recommended that misfired shells not be placed in your pocket or pouch containing other ammunition.
- 3.5 On the skeet, trap, and country-doubles ranges, no hand-held or portable traps may be used. No unauthorized devices or equipment may be used on, attached or connected to the skeet, trap, and country doubles ranges' equipment. Exceptions may be granted by Board of Directors members, including Range Officers.
- 3.6 On the skeet, trap, and country-doubles ranges, only clay targets may be used. Other targets must be approved by the Range Officer or a Board of Director member.
- 3.7 On the skeet, trap, and country-doubles ranges, shooters may not advance to the next station until all shooters in the group have completed the current shooting station. Shooters waiting must be in the safety zone behind the current station. Spectators may not be on the walkways between shooting stations during any shooting activity; moreover, spectators are restricted to observe from the covered shelter and are required to have ear and eye protection.
- 3.8 All persons on the shotgun fields will refrain from passing in front of or conducting activities in an area in front of the open house window where one is in danger of being struck by a released clay target; this is especially possible to occur at the Skeet Low-House Station 7 and the Country Doubles Field.
- 3.9 The use of the skeet, trap, and country doubles ranges shall be limited to thirty (30) minutes or one regulation round of skeet, trap, or country doubles if other groups are waiting. Generally, as a courtesy to other shooters, shotgun shooting squads should not exceed five (5) members. Squads should yield to the next squad awaiting to shoot and rotate shooting squads.
- 3.10 **You are responsible for cleaning up the ranges** when you have completed your shooting. All shotgun hulls must be removed from the range surface and disposed of in an appropriate manner. Empty clay

boxes and other large cardboard containers shall be removed from the range and placed in the fence container under the pavilion next to the cardboard compactor.

3.11 All members are required to be instructed by a knowledgeable member or Club Officer in the use and loading of the clay throwing machines to ensure all safety and operating procedures are known and understood. You are charged with the duty, after shooting, to:

- a. Turn off the machine.
- b. Release the arms of the clay throwing machines.
- c. Reload each clay throwing machine with clay birds.
- d. Load new clays to each house so there are not less than 8 boxes for use or leave a notice that the houses are low on clays.
- e. Sweep out the house, remove and dispose of empty boxes and trash.
- f. Return the trap transmitter to its proper place. Shut/close the trap doors.
- g. After shooting and before leaving the Trap, Country Doubles or Skeet Ranges, if used, roll up the release cords and place them in the storage facilities.
- h. Lock the clay throwing houses.
- i. DO NOT attempt to adjust, modify, or repair any clay target throwing machine. Report the malfunction or repair requirement to a Club Officer or deposit a note in the cash box describing the malfunction or repair requirement.

3.12 **No shot size larger than #7½ shall be used on the skeet, trap, and country-doubles (shotgun) ranges**, no tracer or incendiary type shells shall be used. **Permitted shot size is restricted to sizes 7½, 8, 8½, and 9 only.** This rule is mandated by safety requirements, and there are no exceptions. Violators will be subject to suspension of membership and presence upon the Club property, whether temporary or permanent, and trespassing charges may be presented to those who violate any suspension.

3.13 **Only legal, modern-style 12, 16, 20, 28 gauge and .410 bore shotguns may be fired on the Shotgun Fields;** and, specifically, this is to include and be limited to single-shot, over/under, side-by-side, pump-action and auto-loading or semi-auto action shotguns. **Under no circumstances**

shall handguns (pistols/revolvers ... *Taurus "Judge", Smith & Wesson "Governor", etc.*) be used. Black powder shotguns may be used on the skeet/trap/country doubles fields.

#### **Section 4 - Archery Range Rules**

- 4.1 Inspect equipment for damage prior to shooting.
- 4.2 Check arrows for cracks, loose vanes, bends, broken nocks or any other condition that may cause the arrow to fly erratically or to rupture when released.
- 4.3 Check bows for frayed strings, loose pulleys, warped limbs, cracks or other damages that may result in breakage when at full draw. When a pool of equipment is used by several student archers over several weeks or months, inspect after each use.
- 4.4 Shoot only those arrows matched to the shooter's draw length with spines matched to the bow's draw weight.
- 4.5 Never "dry fire" a bow. The resistance of an arrow is needed to prevent damage to the bow limbs.
- 4.6 Never draw another person's bow. Draw length and pull weight vary with each shooter.
- 4.7 Never overdraw a bow intentionally.
- 4.8 When broad head arrows are not in use, cover the razor tips with an approved sheath.
- 4.9 Check surroundings before drawing a bow to shoot. Tree limbs, low ceilings or other items may obstruct the bow's action.
- 4.10 Use proper gear, including arm guards, to prevent string burns and bruises to the forearm, finger tabs and releases to protect fingertips and bow slings to maintain control of the bow.

#### **Section 5 - Administrative Range Rules**

- 5.1 **Club members are responsible for any guests they may bring on Club property.** This includes making the guest aware of all range rules and regulations before that guest or guest(s) uses the club facilities. If the

member leaves the premises, their guest(s) must leave also. No unaccompanied guest(s) are allowed. Additionally, the Board of Directors shall establish and post a fee schedule for the use of the Club's facilities, including all ranges and fields. **(See Attachment "A" (p. 19) for current member/guest fees)**

- 5.2 **All members and their guests must sign-in at either the sign-in sheet on the front porch of the Clubhouse or the Rifle/Rim fire and/or Handgun ranges.** In addition, Member's guest(s) must sign a liability release form before using any ranges. If you are a returning guest and have previously signed a liability form you MUST sign another form. Forms are located in the sign-in boxes at each range. Members and their guest(s) who are found on the premises and who have not signed in, will be asked to sign-in or leave the premises. **Non-Members found on the Club property without the company of a member may be charged with misdemeanor trespass; and, if in the possession of a firearm, it constitutes felony trespass.**
- 5.3 Your **Membership ID card furnished to you should be in your possession at all times while on the Club property.** Members, guests or visitors who fail to identify themselves to a Range Officer, Club Member or any Board of Directors Member may be asked to leave the range, subject to temporary or permanent suspension of membership or may be charged with trespassing.
- 5.4 Any designated Range Officer controls the range. All directives from that person must be followed immediately. Appeals of the directives may be brought to the Board of Directors, but the directive must be followed at the time it is given, unless doing so would endanger the safety of people on the range. **All members of the Board of Directors are *de-facto* Range Officers, and it is the incumbent duty of all members to see that conduct on the ranges follows these Range Rules and Safety Plan.**
- 5.5 During all events or competitions there is to be a designated Event Coordinator. The role of which is to take responsibility for managing an organized competition. In addition, there are to be an adequate number of Range Safety Officers present during all competitions to ensure a safe competition for all participants and spectators.
- 5.6 Animals (pets) are not allowed in the range area without a leash and being under owner control. Wild or domestic animals that may enter the range

area shall be run off, not by shooting at them. If a wild or domestic animal enters the range area, a cease-fire shall be called until the animal is off the range.

- 5.7 **Hours of Operation: Monday - Saturday 8:00 AM to Sunset. Sunday 12:00 Noon to Sunset.**
- 5.8 Fires, open flames, propane, or charcoal-fueled cooking devices are prohibited on the property except in designated areas or as approved by the Board of Directors.
- 5.9 Club facilities may be reserved by submitting a letter to the Board of Directors describing in detail the member's event. A one-month advance notice is required.
- 5.10 **Every member** using the facilities is responsible to ensure the rules are followed. Everyone shall report violations of these Range Rules and Safety Plan and/or unsafe circumstances to a Range Officer or other member of the Board of Directors. Confidentiality of the person making the report will be maintained if requested and circumstances so warrant the confidentiality.
- 5.11 No notices or signage shall be posted on any part of the facility without the permission of the Board of Directors. The only exception is that a notice of a safety problem may be posted. If a safety notice is posted, then any member of the Board of Directors is to be notified immediately. Contact information for Board of Directors members is located at the club house.
- 5.12 All members must acknowledge receipt of this *Range Rules and Safety Plan*, including acknowledgment of the proper use and operation of the skeet/trap/doubles .22 LR Only range and rifle/handgun ranges. You cannot utilize these facilities until you have attended the required in person orientation of the Range Rules and Safety Plan.
- 5.13 Whenever 9-1-1 is called or emergency response personnel are called to the Range or Club property or for any incident requiring professional medical attention, the **physical location of the Club property is 902 East Bailey Street.**

- 5.14 No construction on, alteration to, digging or depositing of soil, planting or removal of vegetation or any modification to the range and or related facilities is allowed without the prior approval of the Board of Directors.
- 5.15 These rules may be changed, amended, or rescinded at any time with majority vote and approval of the Board of Directors.
- 5.16 All federal, state, and local laws in addition to all Club Rules, Safety Plan and regulations shall be obeyed while on Club property.
- 5.17 All principal Club members must be at least **21** years of age. All Club members, families and guests must be accompanied by the Club member when visiting the Club's facilities. **NO family member or guest, under 21 years of age may be left alone when on the Club grounds whether shooting or not. An adult principal member must maintain constant and immediate supervision of minors and guests.**
- 5.18 Card-carrying members of the club are allowed two (2) guests on the rifle and handgun ranges. In addition, up to four (4) guests are allowed on the shotgun ranges for the purpose of forming a full squad of five (5) shooters. In all cases the card-carrying member must accompany their guest(s) on site. Furthermore, it is the card-carrying member's responsibility to familiarize their guest(s) regarding the policies and safety procedures of the club.
- 5.19 Charged Duty to Member in Proper Use of Facilities
- a. Ensure the entrance gate is shut and locked with the chain after entering or leaving the premises.
  - b. Ensure the Clubhouse is secured, by:
    1. stove, fans, air conditioners, etc., are turned off
    2. door and windows are closed and locked
- 5.20 **Recreational riding of ATV's, 4-wheelers, golf carts or any like-motorized or utility vehicle is EXPRESSLY PROHIBITED** except that same may be used for (a) use in transport of clays from storage to the field houses and transport of maintenance/building materials, (b) use in service for trash disposal and landscape services, (c) use by the handicapped and (d) use in club-organized events. This does not pre-empt use of motorized wheelchairs by the handicapped.

**ATTACHMENT "A"**  
**CUERO SPORTSMAN CLUB, INC.**  
**RANGE FEE SCHEDULE**

The Cuero Sportsman Club, Inc. uses the honor system to collect fees for the use of the various ranges and fields, including the archery, handgun/rim fire and rifle ranges and the skeet, trap, country double fields and other ranges as may be developed. It is imperative that each Club member pays their fees for these services and to ensure the family member's fees and their guests' fees are also paid.

**The current range fee schedule is as follows:**

**RIFLE 100-YARD RIFLE RANGE and**

**HANDGUN/RIM FIRE 15-25-50-YARD RANGES**

1. **No Cost** per day for Principal Members, their spouse and/or their children under 21 years of age living in the principal member's household.
2. **\$10.00 CASH** per day for Guests (includes Principal Members' children 21 years of age and older who do not have their own membership).

**ARCHERY RANGE**

1. **No Cost** per day for Principal Members, their spouse and/or their children under 21 years of age living in the principal member's household.
2. **\$10.00 CASH** per day for Guests (includes Principal Members' children 21 years of age and older who do not have their own membership).

**TRAP - SKEET - COUNTRY DOUBLE SHOTGUN FIELDS**

1. **\$5.00** per round for Members or one (1) coupon.
2. **\$10.00** per round for Guests or (3) coupons.

*Note: A skeet, trap or country doubles "round" is considered 25 target/clay birds; therefore, each 25 clays shot, whether or not in a match or official round, is considered a "round" and machine-broken clays are not counted. (trap doubles = 2 rounds; 2 coupons or \$10 cash for members; 6 coupons or \$20 cash for guests)*

**COUPONS** are available for purchase in **booklets of 10 coupons for \$40.00** (\$4.00 x 10) and are accepted as payment for member-rate fees at the shotgun fields only. **CASH ONLY** (guest fees) on the handgun, archery, and 100-yd Rifle Range. USE FREE **RED COUPONS** for youth age 18 years and younger on shotgun fields.

ALL RANGE USE/TARGET FEES and COUPONS are to be deposited in the boxes located either on the porch of the Clubhouse or at a central location near the rifle/handgun ranges. **FAILURE TO PAY APPROPRIATE RANGE FEES, INCLUDING FAMILY MEMBER AND GUEST FEES, MAY SUBJECT THE MEMBER TO EITHER SUSPENSION OR REVOCATION OF THEIR CLUB MEMBERSHIP.**
